## PUBLIC ACCESS to MONROE COUNTY COURTHOUSE

In order to reduce the risk to the public, while continuing to protect public safety and the legal rights and access of our citizens, the Monroe County Chief Judges have enacted the following regarding entry and use of the Monroe County Courthouse for Returning to Full Capacity.


Members of the public who are not fully vaccinated are required to wear facial coverings, unless medically intolerable. Security must be advised of the intolerance and alternate service measures will be provided.

Employees who are not fully vaccinated must wear facial coverings in public areas and in work spaces where social distancing is not in place.


